

I will avoid any actions that may cause damage, deterioration, or misuse of the event's spaces, structures, furniture, equipment, signage, and other elements, as well as the natural environment surrounding the event.

If I become aware of, or if I accidentally or intentionally cause damage to property belonging to the event, the organization, another participant, or third parties, I will take responsibility for reporting it immediately to the organizing team, and if I am

responsible, I will cooperate in the repair, replacement, or

compensation for the damage.





Environmental Responsibility

- I will follow all guidelines related to recycling and waste management to maintain proper conditions in all areas where JamCam 2025 takes place.
- I will keep my personal space and all shared spaces clean and orderly.
- I understand that lighting campfires is prohibited in areas not designated by the event's organizing team.

- I understand that adults are prohibited from entering the participants' camping areas unless they have a specific and clearly assigned role that requires their presence. (On January 1st, during the Day of the Americas celebrations, the plazas of the Jamboree and Camporee subcamps will be considered common areas, allowing access to all adult participants only within these specific spaces of the
- → I will not enter tents, restricted areas, or private spaces unless I am explicitly invited, and only when doing so does not violate the access restrictions established for each area.

I will not sell any item that has not been authorized for sale by the JamCam 2025 organizing team.

→ I understand that the use of drones, bicycles, and fireworks is prohibited without prior authorization

from the event's organizing team, as well as the use of laser pointers or laser beam devices.

- Except in emergency situations, any departures not included in the official JamCam 2025 program must be authorized by the Camp Chief or the International Service Team Coordination, together with
- the Head of Delegation.

Compliance with the Established Chain of Communication

access permissions, or immediate expulsion from the event without refund and at the expense of the individual in violation.
